Environmental Policy

Purpose

At INNIO, corporate social responsibility is inextricably linked to our DNA. Through our products and operations, we are determined to make the world a better place. We are committed to the environment and reducing the footprint of our business operations by identifying, measuring and offsetting the environmental impact of our global operations. Therefore, we commit to consider the environmental impact of all our choices—including material, component, product, service, packaging and transport options. We work to determine the best processes and techniques that are economically and ecologically reasonable.

In addition, we recognize our responsibility regarding the environmental impact of our product designs and are working to drive even lower emissions and higher efficiencies for our engines. We also intend to encourage environmental stewardship by expanding our ReManufacturing program.

At INNIO in Jenbach by 2030 we aim to:

- achieve electricity self-sufficiency and reduce CO₂ footprint by 50% *
- → recover more than 80% of our non-hazardous waste
- avoid hazardous waste generation
- → eliminate plastic packaging from our production site
- → reduce our municipal wastewater

- → reduce the chemicals used at our production sites by 20%
- enhance the outside environment at our production sites to promote small animals and insect life
- develop innovative mobility concepts to reduce emissions from commuting

- → We will continue to treat our resources with care and responsibility. This includes the preservation of all natural resources such as land consumption, soil, water, air, materials and energy sources.
- → We aim to lower our impact on the environment by reducing all emissions (waste, wastewater, air pollutants, heat, etc.) through avoidance, reduction and recycling.
- → We respect the five steps of the waste hierarchy: Prevention, Reuse, Recycle, Recover, and Disposal. We attempt to apply this strategy to all areas of the environment.
- → We do our utmost to implement projects and innovations that reduce our greenhouse gas (GHG) equivalent. On our path to CO₂ neutrality, we compensate through sustainable carbon offsets according to PAS 2060:2014 until we can avoid GHG emissions completely.
- → We evaluate our environmental and energy performance and our key performance indicators. We perform internal and external audits, learn from them and continue to develop according to the Plan-Do-Check-Act cycle.

- → We seek to prevent incidents but have well-defined action plans prepared should they be needed.
- → We enable, inspire and train all our employees to act in accordance with this policy.
- → We communicate the performance of our environmental policy, processes and products to all internal and external stakeholders, including authorities and the media.
- → We have integrated our environmental and energy management systems into our ISO-certified Integrated Management System (IMS) and have assigned clear responsibilities, goals, programs and documentation.

With this policy, we include our customers, suppliers and all other external stakeholders.
